

## ANYTHING STORE

Subject to approval by U.S. PROFESIONALES DE EL SALVADOR, S.A. DE C.V, entities that have been accepted as registered with [www.employeegold.info](http://www.employeegold.info) may purchase any item that is legally sold by any entity, in jurisdictions where the purchase may not otherwise be prohibited, by using SPURT belonging to U.S. PROFESIONALES DE EL SALVADOR, S.A. DE C.V., as collateral for self-liquidating commercial credit with TEXAS HOLDINGS, INC., with no out-of-pocket funds being required.

To do so they must follow the protocol shown in <http://www.change2100.com/THIBMART/SPURT.pdf>, they must cooperate with an INDEPENDENT CONTRACTOR to issue PURCHASE ORDERS and REPURCHASE AGREEMENTS as per [http://www.change2100.com/THIBMART/FIRST\\_TRANSACTION.pdf](http://www.change2100.com/THIBMART/FIRST_TRANSACTION.pdf), and they must work with the CONTRACTOR to arrange for FIDES GESTION FINANCIERA, S.A. DE C.V., SOFOM ENR to use the services of a commercial bank that has signed a FIDES SERVICES CONTRACT or a PRIVATE LENDER that has signed a FIDES JVA or a FIDES IBOE JVA so that FIDES may provide funds in the necessary currency through the INVAG protocol.

Entities that already have UNITED STATES DOLLARS value, which originated with TEXAS HOLDINGS, INC 2016 BUSINESS MODEL, deposited with FIDES, may use that value and start with a FIDES IBOE JVA and then the INVAG process, without being required to follow the SPURT requirements.

As stipulated above, the ANYTHING STORE process does not require out-of-pocket funds; but, there is a business promotion requirement.

**In keeping with the registration requirement of EMPLOYEE GOLD, to actively participate in advertising, the requirement for use of the ANYTHING STORE is to provide an INDEPENDENT CONTRACTOR a business referral that purchases UAWS or SUPER UAWS, as may be determined by the INDEPENDENT CONTRACTOR and the CENTER through which the INDEPENDENT CONTRACTOR submits the business.**
