

IEC PURCHASE SUPPORT CONTRACT IEC-XXX001

March 5, 2015

Whereas, Members of the Internet Catalogue Club (hereinafter "ICC") may acquire TICKETS-USD-IEC issued by ICC representing 40% of the value of a purchase the Member wants to make of legitimate items sold by any legitimate vendor anywhere in the world;

Whereas, [full name of ICC Member] is holder of ICC Membership #[number] (hereinafter "MEMBER");

Whereas, INTERNATIONAL ENERGY COOPERATIVE (a Texas DBA for TEXAS HOLDINGS, INC.; hereinafter "IEC") may arrange for use of DOCUMENTARY FUNDS (hereinafter "DOC FUNDS") which are guaranteed payable by FIDES GESTION FINANCIERA, S.A. de C.V., SOFOM, ENR (hereinafter "FIDES") to be used as per "FIDES BT PLAN" as published in www.chips-corner.com;

Whereas, IEC may arrange contracts as per the "FIDES BT PLAN" for ICC Members;

The parties hereto hereby agree and covenant that:

CLAUSES

- 1) The parties hereto hereby make the PREAMBLE hereof part of the CLAUSES hereof by this reference thereto.
- 2) The full information, in detail, of the items, price, and the Vendors of the items that MEMBER wishes to acquire using the facilities and protocols of the 70 Percent DISCOUNT STORE as published in www.chips-corner.com, is as per Attachment I hereto which the parties hereto hereby make part hereof by this reference thereto.
- 3) The total value of all items to be purchased is [amount in words] (\$[x,xxx.xx]) USD (hereinafter "PURCHASES").
- 4) TICKETS-USD-IEC offered by ICC that are ordered through ICC and acquired by MEMBER, with value at forty percent of PURCHASES, shall automatically be resold to IEC.
- 5) IEC shall arrange to lodge funds with FIDES, equal in value to the TICKETS-USD-IEC acquired by MEMBER as per this contract, and resold to IEC, and obtain a FIDES annual contract with a face value equal to the value of the TICKETS-USD-IEC and accruing 10% annual interest, with the Beneficiary of this FIDES annual contract being MEMBER.

- 6) The above mentioned FIDES annual contract shall provide payment in full by IEC to MEMBER for the TICKETS-USD-IEC purchased from MEMBER by IEC.
- 7) IEC shall obtain and allocate TICKETS-USD equal to 30% of PURCHASES to the 70 PERCENT DISCOUNT STORE on behalf MEMBER, at no further cost to MEMBER.
- 8) MEMBER shall abide by all requirements of the 70 PERCENT DISCOUNT STORE for MEMBER's order to be processed.
- 9) Each page of this agreement and any attachments thereto or amendments thereof may be initialed, signed, and transmitted electronically.
- 10) A full set of copies of individually initialed and signed pages of this agreement and any attachments and/or amendments:

Has the same validity and force of law as an original initialed and signed agreement.

- 11) The applicable law by which this agreement shall be construed and interpreted is:

“The United Nations Convention on Contracts for the International Sale of Goods” (CISG, made in Vienna, 1980)

- 12) In the event there arise conflicts requiring judicial resolution, the conflicts shall be resolved without further recourse:

A) By arbitration as per “The Vredespaleis” located in The Hague, The Netherlands (see www.vredespaleis.nl);

B) With any conflict requiring resolution to be presented at either “The International Court of Justice” or at “The Permanent Court of Arbitration”.

- 13) A party wishing to make use of arbitration shall be required to arrange for such judicial process and take full and sole responsibility for covering all expenses related thereto.
- 14) If the arbitration rules in favor of the party initiating the mentioned arbitration all the expenses of the arbitration process will then be reimbursed by the defaulting party.
- 15) Decision by arbitration shall be presentable in any Court of competent jurisdiction for enforcement.
