# ANSWER TO PROBLEM:

(THE EXAMPLES BELOW ARE CALCULATED ON THE BASIS OF \$5,000 IN UAWS PER MILLION USD REQUIRED VERSUS THE CURRENT REQUIREMENT OF \$10,000 IN UAWS PER MILLION USD REQUIRED. THE EXAMPLES FIGURES WOULD NEED TO BE ADJUSTED ACCORDINGLY.)

Subject to acceptance by USPES, a firm may issue PRO-FORMA INVOICES to TEXAS HOLDINGS, INC to sell items as may be requested by TEXAS HOLDINGS, INC.

## **TRANSACTION A**

Subject to approval by TEXAS HOLDINGS, INC, the firm may issue a PRO-FORMA INVOICE to sell items to TEXAS HOLDINGS, INC and charge a total of \$1,140,000,000,000 UNITED STATES DOLLARS, including a total profit of \$380,000,000,000 UNITED STATES DOLLARS, with one half paid by the CONTRACTOR to USPES, leaving the CONTRACTOR **a net profit of \$190,000,000,000 UNITED STATES DOLLARS.**

**The CONTRACTOR's net profit may be used to pay the required taxes.**

However, to issue the PRO-FORMA INVOICE the CONTRACTOR would be required to purchase 5,700,000 UAWS at a cost of \$1,000 UNITED STATES DOLLARS each, providing up-front a payment of \$5,700,000,000 UNITED STATES DOLLARS – **much less than the amount otherwise to be paid for taxes, but still a lot of money!**

## **TRANSACTION B**

Subject to approval by TEXAS HOLDINGS, INC, the firm may issue a PRO-FORMA INVOICE to sell items to TEXAS HOLDINGS, INC and charge a total of \$34,200,000,000 UNITED STATES DOLLARS, including a total profit of \$11,400,000,000 UNITED STATES DOLLARS, with one half paid by the CONTRACTOR to USPES, leaving the CONTRACTOR **a net profit of \$5,700,000,000 UNITED STATES DOLLARS.**

**The CONTRACTOR's net profit may be used to pay for the UAWS for TRANSACTION A.**

However, to issue the PRO-FORMA INVOICE the CONTRACTOR would be required to purchase 171,000 UAWS at a cost of \$1,000 UNITED STATES DOLLARS each, providing up-front a payment of \$171,000,000 UNITED STATES DOLLARS – **much less than the amount otherwise to be paid for UAWS required for TRANSACTION A, but still a lot of money!**

## **TRANSACTION C**

Subject to approval by TEXAS HOLDINGS, INC, the firm may issue a PRO-FORMA INVOICE to sell items to TEXAS HOLDINGS, INC and charge a total of \$1,026,000,000 UNITED STATES DOLLARS, including a total profit of \$342,000,000 UNITED STATES DOLLARS, with one half paid by the CONTRACTOR to USPES, leaving the CONTRACTOR **a net profit of \$171,000,000 UNITED STATES DOLLARS.**

**The CONTRACTOR's net profit may be used to pay for the UAWS for TRANSACTION B.**

However, to issue the PRO-FORMA INVOICE the CONTRACTOR would be required to purchase 5,130 UAWS at a cost of \$1,000 UNITED STATES DOLLARS each, providing up-front a payment of \$5,130,000 UNITED STATES DOLLARS – **much less than the amount otherwise to be paid for UAWS required for TRANSACTION B, but still a lot of money!**

## **TRANSACTION D**

Subject to approval by TEXAS HOLDINGS, INC, the firm may issue a PRO-FORMA INVOICE to sell items to TEXAS HOLDINGS, INC and charge a total of \$30,780,000

UNITED STATES DOLLARS, including a total profit of \$10,260,000 UNITED STATES DOLLARS, with one half paid by the CONTRACTOR to USPES, leaving the CONTRACTOR **a net profit of \$5,130,000 UNITED STATES DOLLARS.**

**The CONTRACTOR's net profit may be used to pay for the UAWS for TRANSACTION C.**

However, to issue the PRO-FORMA INVOICE the CONTRACTOR would be required to purchase 154 UAWS at a cost of \$1,000 UNITED STATES DOLLARS each, providing up-front a payment of \$154,000 UNITED STATES DOLLARS – **much less than the amount otherwise to be paid for UAWS required for TRANSACTION C, but the initial cost may still be reduced!**

### **TRANSACTION E**

Subject to approval by TEXAS HOLDINGS, INC, the firm may issue a PRO-FORMA INVOICE to sell items to TEXAS HOLDINGS, INC and charge a total of \$924,000 UNITED STATES DOLLARS, including a total profit of \$308,000 UNITED STATES DOLLARS, with one half paid by the CONTRACTOR to USPES, leaving the CONTRACTOR **a net profit of \$154,000 UNITED STATES DOLLARS.**

**The CONTRACTOR's net profit may be used to pay for the UAWS for TRANSACTION D.**

However, to issue the PRO-FORMA INVOICE the CONTRACTOR would be required to purchase 5 UAWS at a cost of \$1,000 UNITED STATES DOLLARS each, **providing up-front a payment of only \$5,000 UNITED STATES DOLLARS!**

**Thus, after becoming a CONTRACTOR with USPES and starting with TRANSACTION E, then D, then C, then B, then A, a tax bill of \$190**

**Billion UNITED STATES DOLLARS may be paid through earnings received!**

**Isn't that a better way to pay taxes?**

**Perhaps someone should inform ACACIA!**

**Perhaps anyone that has a tax bill might want to structure a similar process for payment!**
