Subject to approval by TEXAS HOLDINGS, INC, why not use the \$6 Million UNITED STATES DOLLARS to purchase 200 LIVE ADVERTISING packages, receive a rebate of the \$6 Million UNITED STATES DOLLARS, plus \$1,200,000,000 UNITED STATES DOLLARS by reselling the advertising to TEXAS HOLDINGS, INC; all deposited with FIDES GESTION FINANCIERA, S.A. DE C.V., SOFOM ENR?

Subject to approval by TEXAS HOLDINGS, INC, why not use \$945 Million UNITED STATES DOLLARS to purchase 31,500 LIVE ADVERTISING packages, receive a rebate of the \$945 Million UNITED STATES DOLLARS, plus \$189 Billion UNITED STATES DOLLARS by reselling the advertising to TEXAS HOLDINGS, INC; all deposited with FIDES GESTION FINANCIERA, S.A. DE C.V., SOFOM ENR?

That would provide \$30,000 + \$6,000,000 + \$1,200,000,000 + \$189,000,000,000 UNITED STATES DOLLARS on deposit with FIDES GESTION FINANCIERA, S.A. DE C.V.

Subject to approval by TEXAS HOLDINGS, INC, \$190 Billion UNITED STATES DOLLARS from that deposit could be provided as payment for the taxes, leaving \$206,030,000 UNITED STATES DOLLARS on deposit.

Subject to approval by TEXAS HOLDINGS, INC, The taxing authority could use the funds within FIDES, could provide them to FIDES for use in non-depletion non-risk transactions to produce profits, and/or could assign a bank to sign a FIDES SERVICES CONTRACT and transfer the funds to any institution through the services provided as per that CONTRACT.

Isn't that a better way to pay taxes?

Perhaps someone should inform ACACIA!

Perhaps anyone that has a tax bill might want to structure a similar process for payment!
